- ❖ The bidder shall upload all mandatory documents mentioned in Bidding Document at EPAD, excessively 200MB they are required to submit non-mandatory supporting documents physically at the time of technical bid opening with evidence in light of SPPRA guidelines dated 15.04.2025, as circulated earlier vide letter dated 16.04.2025.
